As per FICCI REPORT on issue of fake pesticides in India highlights:

- •The issue of counterfeit pesticides of the domestic pesticide industry ~25% by value.
- Around 10.6 million tons of food production could be lost due to illegal pesticides.
- •Food grain exports worth ~INR 1, 5780 crores could be at stake.
- •Exports of \sim 3 million tons of fruits & vegetable worth \sim INR 880 crores could also be at stake.¹


Gujarat ACF Awareness Campaign
